Federal Updates

- Senate released HEALS Act:
 - \$15 billion for child care
 - × \$5 billion to child-care providers
 - **\$10** sillion for "back to work child-care grants"

If you would like to compare the supports offered to children and families in the HEALS Act and the HEROES Act, access Voices for Georgia's Children's <u>comparison chart</u>.

FY 2021 Appropriations:
 The LHHS bill increases 21st CCLC by \$13 million

• House Passed Two Child Care Bills:

- Child Care is Essential Act (providing \$50 billion for CCDBG)
- Child Care for Economic Recovery Act (increases mandatory CCDBG funding and expands child care tax incentives and deductions)

Afterschool Alliance, the Bipartisan Policy Center, and others <u>called on</u> <u>Congress</u> to include at least **\$6.2 billion** in 21st Century Community Learning Center afterschool program support.
