As we prepare for the next month's ASYD conference let's begin to look more into the ASYD Quality Standards these next few weeks leading up to the conference.

- The Georgia Afterschool & Youth Development (ASYD) Quality Standards are a collaborate project that is funded and endorsed by the Georgia Department of Education, the Georgia Division of Family and Children Services, the Georgia Department of Public Health, and the Governor's Office for Children and Families. The development of the Standards was also informed and supported by an array of experts in the fields of education, youth development, public health and juvenile justice.
- Georgia's Afterschool and Youth Development Quality Standards are grounded in the widely held and well-established understanding that children, youth, and families benefit when programs increase their capacity to realize their mission by providing high quality programming. The Standards were carefully crafted to ensure that each standard and the supporting indicators are evidence-based, reflect current best practice and correlate with positive intermediary and longterm outcomes in youth. The Georgia ASYD Quality Standards are research-based best practice guidelines that delineate the critical components of high-quality youth development programs. These guidelines are organized by nine distinct categories, entitled quality elements. Each of these nine quality elements includes a series of related standards. The Standards are supported by a set of practice-based indicators that help to illuminate what each standard looks like in the context of a program.

 - Quality Element 2 / Linkages with the School Day
 - Quality Element 3 / Environment & Climate
 - Quality Element 4 / Relationships
 - Quality Element 5 / Health & Well Being
 - Quality Element 6 / Staffing & Professional Development
 - Quality Element 7 / Organizational Practices
 - Quality Element 8 / Evaluation & Outcomes
 - Quality Element 9 / Family & Community Partnerships
