NEW Year 2 Expenditure Report Template Available for Invoicing

[The GSAN team has developed a new expenditure report template for Year 2.](#) Once you receive full approval on your Year 2 afterschool budget amendment, you can begin submitting electronic invoices for expense reimbursement. For those of you using the expenditure report method, please ensure you have updated to this Year 2 invoice template. As you will see, it allows you to draw down simultaneously from the Year 1 ASP pot of money (your "rollover" or balance), your Year 1 SE pot of money and your Year 2 ASP new line items *all within the same invoice*. You continue to have access to Year 1 funds even though we are in Year 2, but for auditing purposes we must all continue to account carefully for these different allocations.

Please note that those grantees using individuals (one-for-one) receipts and other types of documentation for expenses may not need this new template. Also note that if you were not able to successfully pass cross-functional monitoring in Year 1 (applicable only to those selected for Year 1), you may not use the expenditure report method moving forward.

NEW Funding Opportunity: Nickelodeon Community Funds

Nickelodeon is developing a series of community funds intended to instill in kids a stronger sense of agency and provide them with resources and support to bring to life projects that might otherwise go unfunded. They are starting with a pilot phase in partnership with community engagement platform ChangeX and look forward to a broader launch in 2023 with additional partners.

- The [Nickelodeon Community Funds](#) available through ChangeX will support up to 15 groups across Atlanta to start new community projects related to the arts, STEM, play and environmental sustainability. Working with a grown-up co-leader, kids will actively lead these projects and have the chance to shape their communities for the better.
- Leaders who apply for funding to start one of the 10 projects on offer will have 30 days to build a small team and design an action plan. On completing these steps, they will

be eligible for seed funding of up to \$5,000.

- *The Atlanta Metro is defined as including the following counties: Cherokee, Clayton, Cobb, DeKalb, Douglas, Fayette, Forsyth, Fulton, Gwinnett, Henry and Rockdale counties, and the city of Atlanta.*

NEW Resource: PBPA's Black-Led Nonprofit Legal Bootcamp

The [Pro Bono Partnership of Atlanta](#) is [now accepting applications](#) for PBPA's Black-Led Nonprofit Legal Bootcamp 2023! **Application deadline: November 18, 2022**

- Black-led nonprofits are more likely than other nonprofits to lack access to funding and connections that can help their organizations grow, particularly during the early stages of their development. Following a highly successful pilot program which was held during the Summer of 2022, PBPA is launching an expanded bootcamp that will begin January 2023 and serve even more nonprofit leaders.
- PBPA is looking for Black executive directors of nonprofits that have a primary purpose to assist low-income or disadvantaged individuals in metro-Atlanta. Ideally, these nonprofits:
 - are less than 3 years old OR the applicant has served as an Executive Director for less than one year;
 - have three active non-related board members; and
 - have a budget of less than \$250,000
