Fidelity Bond Requirements

Is your fidelity bond (or equivalent insurance coverage) in compliance with grant requirements? Since the beginning of the BOOST program, the requirement for the fidelity bond amount has remained the same: **equal to at least 25% of the TOTAL grant award.** As your award increases with each new allocation, this affects your insurance requirements and compliance!

What should I do to ensure I am in compliance?

- Check your fidelity bond (or approved equivalent coverage, such as a crime policy). Is your coverage amount sufficient? It should be equal to at least 25% of your TOTAL award, including any Year 2 increases.
- 2. If your coverage amount no longer meets the requirement, you should take action to update your coverage. Please note that you must be in compliance by the time of your next COI renewal. If you are out of compliance now, you may wait until your coverage renewal to make the needed update. After the renewal date, you will no longer have access to your grant funds if your coverage remains out of compliance.
- 3. Consider the future awards for the 2023-2024 afterschool year and the 2024 summer programming, which are also likely to affect your award total. GSAN encourages you to plan future budgets accordingly and to project any future coverage needs, which will require you to project subsequent award allocations based on your awards to date.

Year 2 Expenditure Report Template Available for Invoicing

For organizations using the expenditure report method for invoice documentation, please ensure you have updated to the recommended <u>Year 2 expenditure report template</u>. As you will see, it allows you to draw down simultaneously form the Year 1 ASP pot of money (your "rollover" or balance), your Year 1 SE pot of money and your Year 2 ASP new line items all within the same invoice. You continue to have access to Year 1 funds even though we are in Year 2, but for auditing purposes we must all continue to account carefully for these different allocations.
